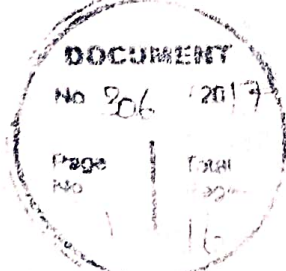

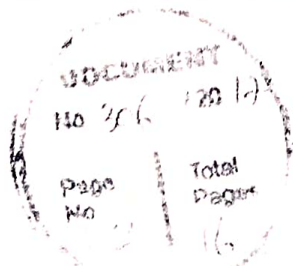
NOW THIS DEED OF DECLARATION OF PUBLIC CHARITABLE TRUST WITNESSETH:

1) NAME

The TRUST shall bear the name K.V.C TRUST.

2) TRUST FUNDS

A sum of Rs.1000/- (Rupees One thousand only) together with further accretion thereto and such other funds which the trustees of the trust may get as donations, investment

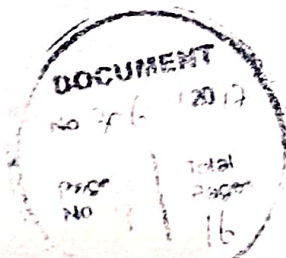

3) Trust Board

The Trust shall be managed by a Board of Trustees consisting of not more than five persons and not less than three persons. The AUTHOR of the TRUST has declared himself to be the Founder and Managing Trustee and shall appoint the other Trustees. In pursuance of such a power, the AUTHOR hereby appoints the following persons as Trustees.

- 1) M. Krishnaswamy (P.A. NO. AAKPK13611)
- 2) V. Sangeetha (P.A. No. ADE PV 9193 N)

On vacation of office by any one or more of the TRUSTEES by reasons of their own volition or death or otherwise, the remaining TRUSTEE(S) shall co-opt additional trustees.

The day-to-day affairs of the Trust shall be conducted by the Managing Trustee. The Trustees shall discuss on important decisions taken by them and shall implement them. In the event of difference of opinion between the Trustees, the decision of the Managing Trustee shall be the final one.

4) Trust's Office

The Office of the Trust shall initially be at 6 (Old 17), First Street, East Abiramapuram, Mylapore, Chennai 600 004 and or such other places(s) as may mutually be agreed upon between the Trustees from time to time.

5) Objects

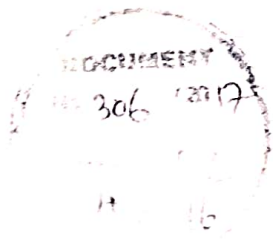
The Objects for which the trust is created are:

i) To provide financial assistance to the needy and poor towards:

- a> Education
- b> Medical Relief
- c> Relief of Poor
- d> Sports and culture

ii) To honour scholars by presenting them with a purse and/or clothes and such other articles on occasions as the Trustees may choose from time to time.

iii) To organize feeding of poor sickly persons or to



contribute towards such poor feeding as the Trustees may decide from time to time.

iv) To conduct training programmes for athletes and other persons and assist them to compete National and International events.

v) To establish, takeover aid and / or financially assist homes for mentally retarded, destitute women, aged people, orphans etc.

vi) To establish and conduct Oriental High Schools, Colleges and other Vidyalayas and Institutions imparting education and research.

vii) To publish and/or aid in the publication of books, journals, periodicals which promote the fulfillment of the objects of the Trust without in any way earning profit thereon.

viii) To celebrate or aid in the celebration of festivals in commemoration of great saints, acharyas, scholars, philosophers by way of aiding and relieving the indigent, poor, deserving, unemployed or incapacitated poor in distress of any caste or creed in India.

ix) To create endowments and to donate funds towards such endowments for purposes awarding prizes, scholarships, financial assistance to outstanding students.

x) To accept any gifts, donations and endowments or properties or monies on such terms and conditions as may be imposed by the donor or donors so as not to incur any liability on the part of the TRUSTEES in furtherance of all or any other objects of the TRUST.

xi) To apply on such religious activities as the Trustees may mutually agree upon from time to time. However, any

property for running the office, schools, patasalas or other educational institutions or hostels or rest houses and such other homes as the trust may decide to run from time to time.

2. To co-operate with other institutions and associations having objects same as those of the Trust.
3. To establish, entities such as Trusts, Funds, Societies for purposes of carrying out the objects of the Trust for purposes of providing benefits for the Trust's employees'.
4. To appoint employees, fix their remuneration and to remove them from service if the situation demands.
5. To enter into agreements with other entities for and on behalf of the Trust.
6. To frame rules regulations, bye-laws for proper administration of the Trust and such other entities as the Trustees may deem necessary from time to time.
7. To acquire fixed assets either on ownership basis or on lease or under hire purchase terms or on rentals for and on behalf of the Trust.
8. To borrow monies from banks financial institutions and other entities as the Trustees may decide from time to time.
9. To execute all such deeds, documents etc. as the Trustees may consider necessary or are required to be executed by them.
10. To appoint professionals as and when their services are required and to fix their remuneration and to give

such religious application shall not exceed such percentage of Trust's income as may be permitted by the Income Tax Act, 1961 from time to time.

xii) To build up corpus out of the monies donated or use the said donation for any of the objects of the Trust hereinabove mentioned as the Trustees may deem fit.

xiii) To adopt villages from rural areas, empower people and bring about all round economic and social development.

xiv) To develop leadership qualities in the youth.

xv) To assist in farm productivity by the introduction of latest technology including organic farming drip irrigation.

The AUTHOR hereby declares that the Trust's charitable applications can either made directly to the needy person or as a support to the family including such an expenditure or directly to the payee for and on behalf of the beneficiary as the Trustees may decide from time to time.

Assistance can also be rendered by the TRUST by acquiring out of its own funds or by way of collecting from third parties, such articles, goods or things as the beneficiary in each such case, may require and by distributing the same to the needy and poor.

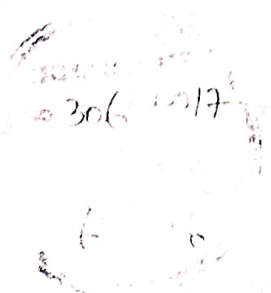
Such application towards financial assistance can also be made to institutions, Trusts, societies, bodies corporate etc. having any of the objects of the TRUST, provided such entities are Charities established wholly for the benefit of public at large.

6) POWERS OF THE TRUSTEES:

1. To purchase, acquire, Lease or otherwise take on rent for Trust's occupation any land, building or immovable

vakalats or power of attorney to such professionals as are required.

11. To have the Trust registered with such statutory authorities having jurisdiction over public charities as the Trustees may decide time to time.

The trustees shall have power to frame and modify by laws for the proper running and maintaining of the institutions run by the Trust.

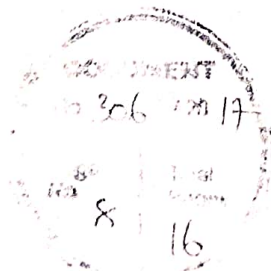
The Trustees shall be entitled to receive donations, contributions and endowments from individuals, charities, companies or other trusts or funds for the objects of the trust on such terms and conditions as may be accepted by the Trustees and such donations may be either to the Corpus of the Trust or to the carrying out of the objects of the Trust which shall be at the discretion of the Trustees and the Donors. The Trustees shall be entitled to donate such sums, as they may deem fit to any charitable trust or institutions having the same objects as those of this Trust.

The Trustees are empowered to borrow money with or without security and utilize the same for the benefit of the Trust and pay interest on such borrowings.

The Trustees shall, from time to time, be entitled to frame, modify and amend the Rules for the purpose of administering the Trust in a smooth manner.

The Trustees for the time being shall in case they so decide shall have power to dissolve the Trust.

Generally, to do all acts and thing and undertake all such works



that are incidental or conducive to the attainment of the objects mentioned in para '6' above.

7) BANK ACCOUNT

The trustees shall open any kind of account(s) with any one or more of the scheduled Bank(s) and such bank account(s) shall be operated severally by any one of the Trustees authorized in this behalf.

All amounts received by the Trust shall be deposited into Trust's bank Account regularly, after retaining sufficient funds to meet the day-to-day expenses.

8) AUDIT

The accounts of the Trust so drawn up shall be audited every year by a Chartered Accountant to be appointed by the Trustees.

9) MAINTENANCE AND CLOSURE OF ACCOUNTS

The trust shall maintain proper books of account and shall have such accounts closed as at 31st day of March every year and surplus or deficit be ascertained.

10) APPLICATION OF TRUST'S INCOME AFTER MEETING ALL EXPENSES

The net income arising out of the Trust properties shall be utilized for all or any of the aforesaid objects as the Trustees may decide from time to time.

11) APPLICATION ON CHARITABLE OBJECTS TO BE ONLY WITHIN INDIA

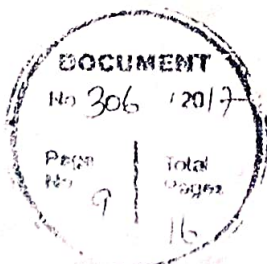
The AUTHOR hereby directs that no part of TRUST'S FUNDS shall be applied on objects outside the territory India.

12) FORMS AND MODES OF INVESTMENTS

The trustees shall ensure that any part of Trust funds not immediately required are invested in such forms and modes as are specified in section 13(5) of the Income Tax Act as amended from time to time.

13) APPLICATIONS NOT FOR PURPOSES OF PROFIT

The AUTHOR hereby declares that the TRUST shall apply its funds on objects stated hereinabove and for purposes

of acquiring such assets as are required for purposes of the TRUST and no part of such application shall be on activities motivated for purposes of earning profits.

14) RESTRICTION ON APPLICATION OF TRUST FUNDS

The Trustees shall ensure that

(i) no part of the Trust's Income enures

or

(ii) any part of such income or any of Trust's property is used or applied directly or indirectly for the benefit of any person referred in Section 13(3) of the Income Tax Act 1961.

15) TRANSFER ON DISSOLUTION

The AUTHOR hereby declares that in the case of the trustees deciding at any point of time to dissolve the TRUST, the trustees for the time being shall ensure that the TRUST'S FUNDS as on such a date is transferred only to another Public Charitable entity and which is having all or any of the objects similar in nature to those of this TRUST.

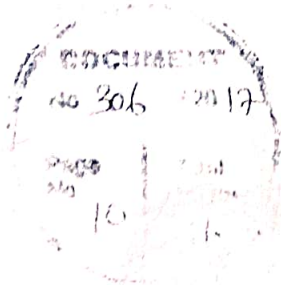
16) DIRECTOR OF INCOME-TAX (EXEMPTIONS) PRIOR PERMISSION

The AUTHOR hereby declares that the trustees of the Trust, for proper working of the Trust are empowered to amend alter modify insert such clauses and terms to this DEED OF TRUST as they may deem fit from time to time.

However, the power so vested in them can be exercised by the Trustees only after obtaining prior approval of the Director of Income Tax (Exemptions) for such proposed rectifications, amendments etc.

17) RESTRICTION ON APPLICATION TRUST'S FUNDS ON OBJECTS OF RELIGIOUS NATURE

The Trustees shall ensure that Trust's funds applied in any year on activities which are of religious nature does not exceed the limit as may be prescribed by the Income-Tax Act, 1961 from time to time.

18) **PRIOR PERMISSION FOR ALIENATION OF IMMOVABLE PROPERTIES**

The AUTHOR hereby declares that the Trustees have been empowered to acquire or dispose of properties both movable and immovable. The AUTHOR hereby declares that trustees shall not make use of such power for alienation of Trust's immovable properties, if any, without obtaining prior approval of the Director of Income-Tax (Exemptions) for such alienation.

19) **BENEFITS TO ENURE**

The AUTHOR hereby declares that the Trust constituted under this deed is a PUBLIC CHARITABLE TRUST and therefore the Trustees shall ensure that its benefits by way of application enure for the public at large without there being any restriction on the selection of beneficiaries as to their caste, creed or religion.

20) **IRREVOCABLE**

The AUTHOR hereby declares that the Trust created under this DEED is IRREVOCABLE.

21) As on date the trust has no immovable or movable properties other than the corpus fund mentioned above.
